1. January Financial Report

James Sluss informed the Committee FY2023 will end with a net zero, no deficit and no surplus. Costs are still higher than expected. Revenue is still being impacted by lack of parking garage revenue and advertising is down.

Dick Maki from Sterling expresses concern about how slowly the numbers are improving. Originally the funding was going to carry until FY2026 and now the funding will be gone in FY2024.

## 1. FY23 Key Financial Drivers

James went over FY23 Key Financial Drivers. MART is trying to reduce costs in all areas. We will be looking at all routes and increasing frequency. We will also be looking at each department for cost reduction, taking over custodial services, increasing subscription service rates and control amount of subscription service clients we take on. We are not obligated to have subscription service but we want to keep the ridership and preform it in an efficient manor with reduced costs. MART will also try to increase brokerage work to generate revenue.
