On the brokerage side MART has been earning more incentives. On the transit side MART is looking at all contracts and pricing structures.

• Purchase of Property at 27 Antietam St, Deven

• Fin Comm Review / Recommendation for Advisory Board Approval Bruno stated the property at 27 Antietam St., Devens (P4 old bakery building) is 1300 square feet of space. MART is looking to invest in this property because we need a place to house transit vehicles east of Fitchburg. Housing vehicles in this area will give us fewer dead head miles.

MART has submitted a grant for \$1 million to rehab the entire building. We should hear in October if we have received the grant. If we don't receive the grant, we can get our original investment back.

• Proposed Fare Structure Changes

• Fin Comm Review / Recommendation for Advisory Board Approval

Bruno informed the committee MART is looking at fares for fixed bus routes and subscription service. Subscription service is not a required/core transit service per FTA. Subscription service was the primary driver of the potential deficit in FY2020 but then we received COVID funds. MART is looking to increase the price of subscription service by 73.3%, if we don't have a price increase, we will not be able to offer this service in the future. We are hoping the price increase will encourage people to use the fixed bus route, where the fare is decreasing.

Dick asked if the introduction of the taxi service is helping with the cost.

James said the taxi service is something we can look at in the future but right now rides cost more using taxis.

MART is looking to reduce the fixed bus route fare \$1.25 reduced to \$1.00 \$0.60 reduced to \$0.50

All students including college students will ride fare free.

MART will also be revising the transfer policy in hopes of increasing intercity ridership.

RESOLUTION- Ken Troup of Bolton moved to approve the price increase for subscription service as presented. The motion was seconded and passed unanimously.
